All papers are submitted by physically visiting the courts and oath is administered to the litigant submitting such documents



Prior to submission of the pleadings in the court, briefings by clients to the advocates, drafting of pleadings, signing of pleadings by the clients by visiting advocates office, payment of court fee etc are performed.



All these aspects are more strenuous when the client, advocate and courts in which the case is to be filed are located in geographically different areas



The e-Filing system is a complete end to end solution developed for online filing of cases. Both Civil and Criminal cases can be filed before any High Court and District Court of the country wherever the e-Filing system is adopted as on date.
