





to be allowed and resultantly the order dated 31/10/2012 passed by the Trial Court rejecting the Application (Exhibit 5) came to be set aside and in turn **injunction** came to be granted to the Plaintiff. 2 The suit in question i.e. Regular Civil Suit No.938 of 2012 has been filed by
